- They will depart for India on 02 August, 2026 or the nearest possible date and return to Bangladesh on 08 August, 2026 or a similar nearest date.
- No extension of stay beyond the approved program duration will be permitted.
- Upon returning, they must submit a report in the prescribed Feedback Form to the Secretary of the Finance Division within 15 days.
